

Nob Hill Main Street (NHMS) seeks to promote public art throughout the district. Previous art projects have been funded on a case by case basis. In the event that a property owner has identified a project and requests assistance from NHMS the following guidelines must be met for consideration:

- The artist, property owner, or tenant must provide some portion of the total budget whether through cash
  or in-kind donation.
- The artist should be able to show examples of work that prove he/she is able to complete a project of appropriate scale in the time provided.
- 3. Durability (quality materials) will be required in a successful proposal.
- 4. Subject matter of the project should be timeless. The chosen artist must consider the local setting and weigh the long-term impact that the piece will have on the immediate environment. NHMS will not fund a public art project that portrays current tenants of a building or property. (For assistance with a project specific to a certain business or organization please request information regarding façade improvement projects)
- 5. Subject matter should portray or celebrate one or more of the following themes:
  - a. The Nob Hill neighborhood, City of Albuquerque, or state of New Mexico
  - b. Route 66
  - c. Local history, character, architecture or uniqueness
  - d. Other themes as identified on a project by project basis
- 6. Artist should consider the Albuquerque Public Art Appropriateness Statement:
  - a. "Proposals for, or existing, Works of Art that include subject matter such as the apparent representation of violence, inappropriate nudity, degradation of individuals of cultures, or desecration of significant cultural symbols, will be reviewed for their appropriateness for public display. Proposals for, or existing, Works of Art that include religious subject matter or symbols may be placed in a public space as long is not in a location where it cannot be revered and is solely for the purpose of exhibiting cultural or historical traditions."

Proposals for public art projects should include 2-4 concept sketches, in addition to a statement appropriately explaining imagery use, meaning and inspirational sources. No more than 100 word count per sketch.

If a concept is selected NHMS board members and staff may work with the artist to finalize details of the concept.

NHMS will fund projects or portions of projects subject to budget constraints and long term organizational goals which are identified on an annual basis.

# Property owner must be financially committed – cash or in-kind

Murals be produced through quality materials
